**Need a copy of your bill?** Duplicate tax bills are available for free on the Internet. Simply go to our website at <u>iasperil.devnetwedge.com</u> and begin your search either by name or property index number. After you enter your information and view your payment status, then select <u>Print Tax Bill.</u> (If you have difficulty retrieving the bill, please remember to set the Treasurer's web site as a trusted site on your web browser.)

**Payment Options:** The Treasurer's Office offers several different options to pay your tax bill. **Pay in person:** 

Walk-in or use the Drive-up window and pay with cash, check, cashiers check or money order at our office located at 204 W Washington Street Suite 4, Newton, IL 62448. (If you do not have your tax bill when you pay, you will be charged a per copy fee.)

## Pay by Drop Box:

**24-hour payment drop box** is located in the **Drive-up** on the west side of the County office building, located at 204 W. Washington St. Payments at the drop box are considered on-time if made on or before midnight on the due date.

Pay by mail: MUST BE POSTMARKED ON OR BEFORE THE DUE DATE TO AVOID INTEREST PENALTY Mail the payment to our office at P.O. Box 107, Newton, IL 62448. Your cancelled check will be your receipt. If you prefer that a receipt be mailed to you, you will need to send a self-addressed stamped envelope along with your payment for us to mail a receipt back to you.

Jasper County Banks can accept your property tax payment if made on or before the due date.

Electronic Payments: Credit/Debit Cards: (MasterCard, Discover, American Express or Visa) and eChecks will be accepted by phone at 833-591-0728 or online at jasperil.devnetwedge.com. (The online payment option will become available after you have reached your parcel's property information.) A convenience fee will be charged by the payment service.

Late Fee: The 1st installment payments are due on or before August 16, 2021. If payment is not received by that day, a late fee of 1.5% will be assessed to that installment. The 2nd installment payments are due on or before September 15, 2021. If payment is not received by that date, a late fee of 1.5% will be assessed to that installment. Both installments may be paid on or before August 16, 2021, with no penalty assessed. 1.5% penalty will be applied to each installment each month until payment is received or sold at the County Tax Sale.

## Certain taxpayers may be eligible for:

- The Senior Citizens and Disabled Persons Property Tax Relief and Pharmaceutical Assistance Act. Applications are available from the Illinois Department of Aging.
- Abatements and/or other assistance programs. You should consult with your township or county assessor and/or the Illinois Department of Revenue.
